## From the Chair and Chief Executive

Last year we took the decision that we would send every member a printed copy of our Annual Report and we're delighted to be able to do so again this year. Resolution is your organisation – we want you to know how crucial your continued support is; and what we're able to achieve for (and with) you as a result.

It continues to be a time of extraordinary change for all involved in supporting separating families. The family courts remain under huge pressure, with budgets cut, ever-increasing numbers of litigants in person in the post-LASPO era, the ongoing bedding in of the regional divorce centres and, early in 2016, the announcement that 86 courts across England and Wales were to close. Our members are changing the way they practice, to meet client demand and ensure they are ready for the heralded modernisation of the family justice system.

Cuts to legal aid continue to have an impact on access to justice and our legal aid members face continued pressures, not least from problems with the Legal Aid Agency's online system.

Against the backdrop of these and other challenges, this Annual Report sets out the many ways in which Resolution has supported our members and the people you help everyday.

2015 saw considerable further success for Resolution. We held our 27th National Conference, which was our biggest yet with over 550 delegates, and included our national launch of YRes, which continues to go from strength to strength.

Our Dispute Resolution Conference also continues to flourish, with our largest event to date in 2015.

We generated the equivalent of £1.2million worth of positive media coverage to get our message across to the public, politicians and practitioners, including our most successful Family Dispute Resolution Week, which generated over 30 million opportunities for the public to see, hear, or read about why they should choose a Resolution member.

We launched our Manifesto for Family Law, the launch event being addressed by the Family Justice Minister, and this has been the cornerstone of our policy and campaigning activity – as it will be for 2016.

And we've looked at new ways to deliver training and to develop resources useful to our members, using technology to help more members access our services.

These and other achievements are only made possible with the support and involvement of our members – and we're proud to include in this report the names of some of the c.1,500 Resolution members who are actively involved in the organisation.

2015 saw over 400 new members join us, so if you're reading your first Annual Report, welcome to Resolution and we hope your name will be on the list of actively involved members in this report in years to come!

As your elected representatives, the National Committee is working year round with the staff team to ensure that the activities carried out by the organisation reflect the needs of our members.

As part of this planning, we have organised our activity under eight broad themes, or 'Future Building Projects'. These form the building blocks for Resolution's work, helping National Committee and the staff team focus their activity on supporting members and their clients in the most effective ways possible.

These themes are:

- Changing Practices supporting our members to deal with the constantly evolving family justice environment.
- Committee Development ensuring members are able to get involved with our work, and share information and expertise.
- Family Law Reform campaigning for changes to family law policy to improve the lives of separating couples.
- Members' Voice ensuring we're talking and listening to members about the issues that matter to you.
- Membership continuing to support all our members and ensuring they're making the most of everything membership has to offer.
- Regional Development being a national organisation with a regional focus, we want to make sure our members are able to make the most of their local networks, and that they have a voice at national level.
- Code of Practice ensuring that our Code remains at the heart of everything we do.
- Training and Learning helping our members with their career development and developing membergenerated training content.

There's more detail about these activities under each theme on the corresponding pages in this report.

2016 sees Nigel Shepherd returning as Chair, having previously led Resolution in the mid-nineties, during another significant period of change, as the 1996 Family Law Act was introduced.

Under Nigel's leadership, we will continue to develop our plans for 2017 and beyond to ensure our Code, our values, our members – and most importantly, the families they support – continue to be at the heart of everything we do.

# Changing practices

1

Resolution's members are working in a consistently changing environment. Legal aid cuts, MIAMs and the Family Justice Review have all meant the role of family justice professionals is evolving. As such, our members constantly strive to create services, training and support to help members provide a first class service to clients in a changing landscape.

One such initiative was the **Family Matters pilot project** that came to an end in September, after 30 months of funding from the Department for Work and Pensions.

Family Matters supported 1,572 parents through their separation during the course of the project, with 95% of them reporting that they found the information and support they received helpful, 78% saying they were better able to take action as a result of our input, and 76% reporting that they better understood the benefits of making arrangements together.

The Family Matters project tested a new way of working with separating couples. Members worked with both parents in an impartial way, using legal knowledge and mediation skills to help them to reach an agreement, and putting them in touch with local sources of support for issues such as housing, debt and health.

Working with Dr Christine Skinner from York University, we carried out **research** into the new practice model. Published in December, this research will feed into other areas of Changing Practices, as well as our future training and learning.

As a founding organisation of the Institute of Family Law Arbitrators, Resolution has worked to **promote family arbitration** and support those offering the process. In 2015 we delivered a new information flyer and developed and launched the new IFLA website aimed at arbitrators, solicitors and separating couples.

In 2015 members agreed to set up a charitable arm of Resolution to allow us to distribute the proceeds of our relationship with Iceberg Client Credit to good causes, and raise funds for charitable activities that reflect the ethos of our Code of Practice. The charity is due to be active in 2016.

Our first Professional Practice
Consultants (PPCs) Forum **brought together over 50 PPCs** from across the
mediation sector, and in 2015 a regular
page dedicated to PPC updates in *The Review* was introduced.

We kept our mediator members up to date with the latest information following the implementation of the mediation Standards Framework through newsletters, the Good Practice Guide on Mediation, and accompanying guidance notes.

## Committee development and member involvement

Without Resolution's committees we could not achieve all that we do. They are a unique asset, ensuring all Resolution's work is delivered by members, for members.

In 2015 we began work to create clearer roles and responsibilities for our committee members. We want to deliver a unified approach to how we recruit, induct and plan for each of our committees, and will build on this work in the year ahead.

Last year we welcomed 220 new members onto Resolution committees and working parties. At the end of 2015, we had a total of 630 volunteer members across these committees and this number continues to rise.

To make sure as many members as possible are involved in planning our work, we have introduced two joint National and Regional Committee meetings per year, two annual National Committee strategy days and a Committee Chairs' Day to ensure members and staff develop and review the organisation's plans together.

In particular, we have worked to make sure junior members from the YRes network are able to join our committees, in order to make their voices heard and ensure that family practitioners at every level of their careers are represented.

As part of this work we opened the YRes network to all members with 10 years PQE or fewer. YRes Chair, Sarah Green, was co-opted onto the National Committee, strengthening the voice of the network further, and providing a critical link between the two groups. We are now pleased to announce the YRes Working Party will become a formal Resolution committee, and will work to recruit additional members from across the country in the coming months.

The achievements of the committees and working parties in the last year have been exceptional. You can find a full round-up of committee highlights on pages 18 and 19, including:

- Updating of the Guides to Good Practice and introduction of several new titles
- The launch of the new Accreditation Scheme
- The coordination of responses to issues raised by members regarding the operation of the family courts
- Delivery of a new version of the separation and divorce booklet for parents

# Family law reform

In 2015 Resolution's members successfully launched a Manifesto for Family Law. This promotes the core policy asks agreed by members across the country, including divorce without blame and basic legal rights for cohabitants. The Manifesto is now central to Resolution's work, focusing our campaigning and helping us to build relationships with key influencers and the new government.

Resolution continued to work closely with partner organisations in the family justice and relationship support arenas. The Manifesto for Family Law was endorsed by Relate, One Plus One, OnlyDads and OnlyMums, the Family Law Bar Association, the Association of Lawyers for Children and others. A major academic research study on divorce law has also begun as a result of the Manifesto.

Family Dispute Resolution Week provided a further opportunity to promote the Manifesto, especially the Parenting Charter supported by the Family Justice Young People's Board, and to engage with MPs and Peers.

We partnered with the Law Society and Legal Aid Practitioners Group to successfully persuade the Legal Aid Agency to delay the roll-out of its online Client and Cost Management System until further improvements were made.

Members worked to influence changes proposed by government and others across the family justice system.

Resolution responded to over 10 consultations on a range of issues, including proposed changes to the court estate, suggested changes to the Family Procedure Rules in relation to children and vulnerable witnesses, the government's review of special guardianship, Home

Office guidance on dealing with Female Genital Mutilation, and the Law Commission's consultation on enforcement of family financial orders. Our Chair appeared before the Justice Select Committee to provide evidence on the impact of increases to courts fees for those divorcing.

In 2015 our family law reform activity created positive media coverage for Resolution's members. Resolution was a **key media commentator** on family law issues including divorce law, the introduction of divorce centres and developments in case law about the financial consequences of divorce. We also worked with the Ministry of Justice (MoJ) and other family justice organisations, including Cafcass and the Family Mediators Association, on the MoJ's Separation Support campaign.

We redeveloped the content on our website for parents facing separation. Launched in Family Dispute Resolution Week at the end of November, the section had over **4,000 views** by the end of December. The accompanying book published in November 2015, *Separation and Divorce: Helping Parents to Help Children* received over **750 downloads** and sold nearly **800 copies** before the end of the year.

## Members' voice



In 2015 Resolution's members' voices were heard by the public, policymakers and professionals.

Resolution members have been regularly featured in the media, commenting on crucial family law issues through initiatives such as Family Dispute Resolution Week.

Into 2015, Resolution generated the equivalent of £1.2m worth of positive media coverage, reaching a combined potential audience of 150 million people over the course of the year.

Spokespeople, including our Chair, regularly featured on broadcast news including Sky News, BBC Radio 4, BBC 5 Live, Newsnight, and comment from Resolution members was regularly included in articles in *The Times, The Guardian, The Independent, The Telegraph* and the *Daily Mail*, as well as the legal trade press.

Across the country members have worked to raise awareness of Resolution's values, particularly during Family Dispute Resolution Week, when Regional Press Officers achieved record coverage for their regions.

Our fourth annual awareness-raising week was our most successful yet, with media coverage once again reaching over **30 million people**. We took our message to Parliament, where we launched our new advice guide for parents, supported by the Family Justice Minister, Caroline Dinenage MP.

Social media played a starring role in last year's campaign, as a result of the huge effort so many of our members put in to promoting our **#childrenfirst** hashtag.

We used the week to launch a new video, which was viewed by over 120,000 Facebook users with over 2,500 clicking through to the Resolution website. Over the course of the week, traffic to the website increased by over a third.

Members also took part in two Twitter Q&As during the week – a first for Resolution. Our campaign hashtag #childrenfirst was used in nearly **4,000 tweets**, and thanks to Twitter activity from our followers, our messages reached over **12 million** people during the week.

Throughout the year, our own tweets about family law and Resolution reached over 1.3m people – and Resolution now has over 8,000 followers on Twitter, an increase of 25% from 2014 – meaning we're able to reach more people more quickly.

The work of Resolution members has also been celebrated through our annual sponsorship of the Legal Aid Lawyer of the Year awards, and Resolution's John Cornwell Award which was jointly awarded to Roger Bamber and Felicity Shedden in 2015.

And we will continue to keep our members informed by email about the latest news, developments in the sector, and information to support them in their day to day work. In 2015 we sent over 60 emails to our different groups of members – that's more than five a month.

# Membership

Resolution is committed to supporting all our members, whether they joined in 1983 when the organisation started, or in 2015. Part of this work is ensuring members are making the most of everything their membership has to offer. It's also sometimes about the behind the scenes work to refine our systems and processes, to ensure our members are fully supported.

For example, during 2015, we introduced a 'welcome' programme for all new members to make sure they have everything they need and to offer any support. To date, Resolution's membership team has **welcomed over** 400 new members using this approach.

We now have almost 30 regional Membership Development Officers (MDOs), who volunteer to support membership, growth and retention in each region. Every spring these MDOs attend a dedicated forum, in order to share best practice and help shape our strategy for bringing new members on board. Each year these volunteers undertake a telephone contact programme - speaking with members who have not yet renewed. In 2015 over 140 additional members renewed their membership following this successful campaign.

In 2015 we continued to improve the website content for members. We launched an **online advice centre** for separating parents, and delivered new member content, including information on international law and the new FMC standards.

The benefits members can access have also continued to evolve. Resolution members have been working with community interest groups OnlyMums and OnlyDads, and many members now offer information and support to separating parents accessing their services.

Their Family Law Panel consists of exclusively Resolution members, who provide a free diagnostic service to parents, enabling families to better understand their situation, and be fully briefed on their options for moving forward. In 2015 OnlyDads and OnlyMums extended this service to provide information and support for those experiencing domestic abuse.

By choosing to work exclusively with Resolution, it has meant members can access a unique and exciting opportunity, which provides them with direct access to market.

The Iceberg Client Credit Ioan product launched in 2014 has to date, proved popular. Members benefit from being able to offer this Ioan at discounted rates to their clients. Last year a number of members asked about the availability of insurance to further reduce any risk, so in response to these enquiries, Iceberg worked with Guarantees and Bonds Ltd, to launch credit insurance.

# Regional development

6

Resolution's 42 regions are the lifeblood of the organisation, providing a crucial link between our members from across England and Wales. This means that Resolution's work is informed by what is happening on the ground, and provides those essential networking opportunities our members find so valuable.

Four years ago we decided to strengthen the regional network by assigning each region a dedicated National Committee (NC) member to provide support and ensure effective two-way communication between NC and the Regions.

This initiative is known as 'Direct Connect' and, under the stewardship of NC member Phil Barnsley, has helped a number of regional committees that were previously struggling to engage members with their work. For example, in 2015 Direct Connect helped Regional Chairs carry out surveys of their members to find out how they can best serve their local Resolution networks.

A regional enews bulletin has also been developed, providing Regional Chairs with crucial information to send out following each Regional Liaison Committee meeting. As a result Chairs are receiving more feedback, ideas and concerns from their local members. Regions also have access to template materials including press releases and model letters to send to MPs.

In the last year, NC members and Resolution staff have, between them, attended nearly **70 regional events**. Joint NC and Regional Liaison Committee meetings now take place twice as often, providing more opportunities for your regional representative and NC to formally discuss issues affecting you and your clients.

Following feedback from members and Regional Chairs, the central delegate fee for regional events and seminars was dropped in 2015. Now all income from events remains within the regions providing more freedom, more flexibility, and more funds to deliver more activity for members.

In order to build a better picture of our regional activity, regional committees now contribute to an events calendar which, in 2015, showed nearly **150 events** such as seminars and training took place, and these are just the ones we know about! The next step is to make the calendar available to all members.

## Code of Practice

All Resolution members sign up to, or endorse the Code of Practice – the cornerstone of our work.

The Code promotes an approach to family law that is sensitive, constructive, cost-effective and most likely to result in an agreement.

Available to every member as part of their membership, our Guides to Good Practice and Guidance Notes build on the Code by developing the ethos behind it into areas of practice. They help demonstrate the way in which the Code should be applied in day-to-day situations.

In 2015 we updated a number of these **Guides and Practice Notes** (available online) including *Mediation, Working with Clients and Preparing Marital Agreements*. We also published new Guides on *Domestic Abuse* and *Working with Vulnerable Clients*.

Resolution is committed to supporting our members to uphold the Code and the values it represents. This is why we rolled out a new complaints procedure in 2015.

With the recent rise in litigants in person, partly as a result of legal aid cuts, it is no surprise that 2015 saw the number of complaints made by self-represented parties rise, often while proceedings are taking place. Resolution is often the first point of contact a litigant has with someone who can signpost them to organisations and information that can help them through the process of separation. We have developed a Guide to Good Practice on *Working with Litigants in Person* to support our members working with this vulnerable group, which has been made available to the public.

Our administration team continues to provide information and signposting when complaints are first received and this often helps to resolve matters informally without the need for a formal complaint to be instigated.

Our complaints procedure is published online with useful information for both members and the public. A complaints toolkit is also available exclusively for members. Resolution's newly appointed **Practice Standards Panel** determines the outcome for those complaints that we were unable to resolve informally. As a result more complaints have been upheld than ever before.

In 2015 we started a review of Resolution's Code in Practice training and will be updating this in the coming year.

In the last year we have introduced a YRes representative attending each Code in Practice training course to ensure all members are aware of the network from the outset of their membership.

# Training and learning

In 2015 Resolution's Training and Learning Committee established a new comprehensive framework for all training and learning offered to members in response to changes to continuing professional development across the sector. The framework operates in a flexible and joined up way that will support members' career development, and provides a clear frame of reference for Resolution to set out the core skills and knowledge areas for family law professionals.

In the last 12 months, all the committees involved in training undertook further work to better support training and learning in Resolution's regions. We have started to **offer our courses locally** to regions and POD groups at a time and location more convenient to them. Increased take up of these courses, has allowed more members to access professional development opportunities in a more cost effective and convenient way.

We have piloted the use of **new technology**, offering more online learning to members. We launched **learn.resolution.org.uk**, which currently includes the new Resolution Guide to *International Family Law*, a new module *Making the most of Resolution membership* and a suite of materials from both the National and DR Conferences.

In the past year members have updated all course materials to ensure they remain fit for purpose and are of the highest quality.

Our Specialist Accreditation scheme, which includes accreditation for Financial Adviser members, continues to support those members who want to enhance their skills and client offering. This year the Specialist Accreditation Committee introduced a Public Children Law accreditation scheme. Over 57 members achieved Accredited Specialist status in 2015 and 262 existing specialists were re-accredited. This means over 1405 members are now Accredited Specialists.

In October, the DR Committee welcomed 169 delegates to Nottingham for our biggest ever **DR Conference**. The packed programme included a panel debate discussing a two client – one lawyer approach to dispute resolution. We were joined by Family High Court Judge Mr Justice Cobb and Jan Walker OBE who delivered our keynote speeches.

The **2015 National Conference** was held in Brighton and once again was a great success. Resolution's committees delivered a diverse programme of workshops to over 400 members.

In 2015 we launched a new Family
Finance Forum, which ran in Leeds and
Guildford, with 132 delegates attending
across the two sessions. Our first one-day
International Conference also took place in
2015 in London. To support those working
within the collaborative process, a two-day
course for Family Consultants and
Collaborative Practitioners was updated
and rolled out to explore the practical
aspects of the process for practitioners.

# YRes – the next generation

Twelve months have now passed since we celebrated the national launch of YRes at the Annual Conference in Brighton, which welcomed 250 YRes members to the two day event.

In April last year the YRes criteria was widened to include members of up to 10 years PQE. This means that there are now 1,613 members who fall into the new category, compared with 918 in the previous year. This change demonstrates the value Resolution places upon its more junior members, and that the organisation is fully focusing on its future membership. Resolution strives to support the future of family law, in line with the work that the next generation of family law practitioners will be required to undertake.

Over the last year we have launched a new YRes flyer to assist with recruiting new members, developed a new YRes area on the public part of the website, secured a regular YRes slot in Resolution's *Review* magazine and popular publication *Family Law*. We also held our second YRes Forum bringing together Chairs from across the country to network and plan for future activity.

The original YRes Working Party members: Sarah Green, Rhian Gray, Rosalyn O'Donnell-Teelan, Joanne Radcliff, Joanna Blakelock and David Lister have since gone on to form the National YRes Committee. Further members of Resolution have recently been invited to join the Committee, so that together they can continue to drive progress and ensure that YRes members remain an integral part of the organisation.

In the two years since the Working Party was created, these six individuals have worked together alongside the Resolution staff team, proving are they are committed to ensuring their contemporaries' interests are considered, and their voices heard. This year Sarah Green was co-opted onto Resolution's National Committee, and work continues to ensure all Committees will have a YRes member on board.

The YRes Committee has received unwavering support from the National Committee, whose approach has been "this will one day be your organisation, you must have the opportunity to help shape it". That is exactly what they are doing.

We are in the process of developing our online platforms so that YRes members can be reached quickly and cost effectively through social media channels. We recognise how our more junior members work differently, as do the resources that are available to them, in a market where profitability is now more important than ever. We are therefore launching a dedicated Twitter account to ensure YRes members have a single point to find out what is happening and where. This will provide more opportunities for members to share ideas and information, and gather ideas for their own regions.

The YRes profile is growing steadily, with a number of regions becoming more active in the last 12 months. Where there were once three or four regions blazing a trail for YRes members, there are now 27 separate YRes groups, who have had the confidence and enthusiasm to bring new ideas, and deliver events and training aimed at their junior colleagues.

The YRes network is ensuring that the links between younger members and the rest of the membership are strengthening, better referral networks are being created and that respect and understanding is built between their peers. This in turn benefits our clients experiencing separation, who can ensure their case is dealt with in accordance with the Code of Practice.

YRes members are Resolution members first and foremost and we must ensure they are supported and developed as the organisation's vanguards of the future.

## Committee highlights

Resolution's committees are fundamental in helping to create and deliver the wide range of products and services we offer to our members. Training, conferences, guidance, and publications are all developed with the help of our volunteers who give their time and expertise to sit on one or more of our many committees.

Our policy work is supported at both a national and local level by our committees, helping shape our campaigning priorities and engaging with the judiciary, politicians, partner organisations and policy makers. Our volunteers also represent the organisation in the media – promoting the outstanding work of our members and the services they offer up and down the country.

In 2015 our committees achieved a tremendous amount. We'd like to share just a few of these achievements here.

#### **Children Committee**

We have continued to promote the Parenting Charter and respond to a range of child-related policy consultations.

## Cohabitation & Equalities Committee

Alongside the Drafting Committee, we have updated the Precedents for Cohabitation Agreements ready for publication in 2016, and raised awareness around the Cohabitation Rights Bill.

## **Dispute Resolution Committee**

We developed and delivered the most successful DR conference to date. We also recruited new members onto the Committee in order to help meet our strategic objectives.

#### **Domestic Abuse Committee**

We have successfully developed guidance and a screening toolkit for Female Genital Mutilation. We have also delivered guidance and a workshop on the disclosure of abuse.

## Financial Adviser Accreditation Committee

We have successfully re-launched the Financial Adviser (FA) Accreditation including the re-writing of the syllabus and prospectus. We have seen the popularity of the FA Accreditation increase in popularity.

#### **International Committee**

We delivered the first international online publication – *Guide to International Family Law*, and one-day conference for Resolution members.

## **Legal Aid Committee**

We have lobbied to bring about changes to the DV gateway, engaged with the LAA to make improvements to the VHCC scheme and helped to delay the compulsory introduction of CCMS.

## Membership Development Working Party

We have continued our work to retain existing members and attract new ones. Membership Development Officers once again successfully contacted members who had yet to renew in order to ensure they signed up for another year.

## **Parenting after Parting Committee**

We updated and delivered a new version of the separation and divorce booklet for parents, and agreed the strategic priorities for the Parenting after Parting initiative.

## **Property, Tax & Pensions Committee**

We provided workshops on pensions and tax, and online briefing notes and updates. We also contributed to the Family Justice Council Financial Needs Working Group and Resolution's response to the Law Commission's formal consultation on enforcement of family financial orders.

## **Skills & Support Working Party**

We delivered a conference 'The family and alcohol in 2015' and have worked to develop skills training, such as managing stress within the new training framework.

#### **Specialist Accreditation Committee**

We launched the new accreditation scheme that offers a range of new specialisms including Public Law Children.


#### **Standards Committee**

We have reviewed and updated the Guides to Good Practice and introduced several new titles. We have also overseen the first year of the new complaints procedure.

## **Training & Learning Committee**

We have created a training and learning framework so that committees can effectively plan and evaluate courses. We have engaged with members and committees to gather their views about current training in order to plan pilot courses.


## Financial overview

In 2015, Resolution's income totalled £2.2m. Of this, over half came from member subscriptions with the bulk of the remainder being generated by training and learning activities.

Our plans for 2015 included extensive project work in the development of products and services for our members. This comprised both our Future Building Projects, outlined earlier in this document, development projects relating to our membership, training and learning services and our website.

Our expenditure represents an ongoing commitment of our reserves, and so our 2015 expenditure exceeded our income by some £105,000. This outcome is well within the parameters originally set for the year by the National Committee as part of Resolution's investment strategy.

In terms of our future plans, £797,323 of our reserves (53%) has been earmarked over the next three to four years for projects to develop new training and learning opportunities for our members, increase our profile with the public,




professionals and policymakers, and to develop new services in line with membership feedback and the changing external environment our members face.

Breakdowns of income and expenditure are detailed below, and the audited accounts can be found in the members' section of the Resolution website.

Although there continue to be many changes in the family law environment, membership numbers remained strong in 2015. This, together with rigorous financial management and investment in services for our members, means Resolution is in a sound position to continue to support members in new and different ways, reflecting the challenges they face.

We will continue to invest in activities in order to raise the profile of Resolution, the work of our members and the benefits of Resolution membership and our code of practice. We will use our resources to support membership development activity – ensuring we can deliver the best possible service to members.
